Remove up to 3m to alleviate weight of overextended branches and to allow more light into properties. RESOLVED: No Objection subject to the usual conditions of the tree officer.

T/22/93821, 46 White's Way, Hedge End. 1 no. Hazel and 1 no. Hawthorn (close to bin stores at 45-65 White's Way) - Prune back up to 2m of material to keep clear of building. **RESOLVED: No Objection subject to the usual conditions of the tree officer.**

T/22/93822, 22 White's Way, Hedge End. 1 no. Oak (close to bin stores at 21-41 White's Way) - Prune back up to 2m of material to keep clear of building. **RESOLVED: No Objection subject to the usual conditions of the tree officer.**

- Cllr Cynthia Garton reported that the speed hump opp the entrance to Ascot Place is worn on the edges.
- Cllr Cynthia Garton also reported that a resident had contacted her regarding the Xelabus Service and potential reductions which Cllr Garton was looking into.
- Cllr John Shepherd reported on Wadsworth Road there is a pothole between Speggs Walk and Coulsdon Road. The pavement is also compromised.
- Cllr Ron Nichols reported the pavement outside Wok Hard paving slabs are loose and a trip hazard.
- Cllr Ron Nichols reported that the repair on the speed hump opposite Westward Road is already deteriorating.
- Cllr Paul Carnell reported the keep left bollard outside of 170 Cranbourne Park has fallen over.
- Cllr Ian Corben has already reported the signage on Tollbar Way has been twisted on the poles.
