H/22/93580, 101 Missenden Acres, Hedge End. Two storey rear extension following demolition of existing conservatory. **RESOLVED: No Objection.**

H/22/93883, 32 Yardley Road, Hedge End. Two and single storey rear extensions and single storey front extension. **RESOLVED: No Objection.**

H/22/93743, 48 Marsh Gardens, Hedge End. Conversion of existing garage to habitable space. Alterations to fenestrations. **RESOLVED: No Objection.**

H/22/93932, 178 Cranbourne Park, Hedge End. Single storey side extension, following removal of conservatory and alteration to fenestration. **RESOLVED: No Objection.**

T/22/93675, Land to the rear of 6 Chalice Court, Hedge End. 1 no. Oak (T58)-Completely remove the lowest branch growing into the conservatory of 7 Chalice Court. Remove whole branch back to main stem. **RESOLVED: No Objection subject to the usual conditions of the tree officer.**

T/22/93869, 11 Mallett Close, Hedge End. 1 no. Ash - Fell. **RESOLVED: No**Objection subject to replanting with something such as a Heavy
Standard Beech (12-14cm girth) and the usual conditions of the tree
officer. If no recommendation to replace then we would object to the
felling of the tree.

T/22/93877, 12 Marlborough Gardens, Hedge End. 2 no. Oak (T1&T2) - Reduce back to old cuts - reducing by approx 1-1.5 m, remove 1 x lowest northern branch on T1 oak. **RESOLVED: No Objection subject to the usual conditions of the tree officer. It would be advantageous to review the TPO on these two trees.**

T/22/93902, 3 Cherrywood, Upper Northam Road, Hedge End. 1 no. Oak (T1) - sharp V-shaped bifurcation, approx. 7 metres from the ground, permission for both limbs of the bifurcation to be reduced by 4 metres because of defect listed. RESOLVED: Object to T1 as insufficient evidence and ambiguity. No Objection to T2 & T3 including a replant of 2No. Silver Birch and subject to the usual conditions of the tree officer.

T/22/93921, 3 Dowds Close, Hedge End. 1 no. Oak - Reduce crown over lawn by approx 3-4 metres in length leaving a crown width of approx 12 metres and crown lift to give 5 metre clearance from ground level to allow more light into
