#### **H638 Highway Matters**

Councillors raised the following Highway Matters with the Town Clerk to seek resolution:

- Cllr Ian Corben reported Marlborough Gardens near Maunsell Way is in poor condition (characterfully described as the moon surface).
- Cllr Ian Corben reported that Bradbeers Roundabout is getting worse despite several reports previously.
- Cllr Ian Corben raised Maypole Roundabout road markings again as it is still confusing residents as to which lane they should be in.
- Cllr lan Corben has already reported the footpath from Maunsell Way towards the Station that connects Martley Gardens. The drain is blocked and the pathway floods.
- Cllr Derek Pretty reported the flooding in Wildern Lane outside Wildern School and also northbound near Westward Road.
- Cllr Derek Pretty raised the Burger King roundabout is getting worse despite several reports previously.
- Cllr Paul Carnell reported the drain outside 1 Thurmell Walk is blocked.
- Cllr Paul Carnell reported the keep left sign is broken near Dodwell Lane.
- Cllr Cynthia Garton identified an issue reported by Community Speedwatch that there is no 30mph sign as you come off the motorway onto Barnfield Way.
- Cllr Cynthia Garton reported a missing bollard on Maunsell Way as you pass the Drummond Road roundabout.
